

FACTS	WHAT DOES ALPHASTAR WEALTH MANAGEMENT (“ALPHASTAR”) DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect, and share depend on the product or service you have with us. The information can include:</p> <ul style="list-style-type: none"> <li>■ Social Security Number and Income</li> <li>■ Account Balances and Transaction History</li> <li>■ Retirement Assets and Investment Experience</li> </ul> <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
How?	All financial companies need to share clients’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients’ personal information, the reasons Alphastar chooses to share, and whether you can limit this sharing.

What We Do	
How does Alphastar protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Alphastar collect my personal information?	<p>We collect personal information, for example, when you:</p> <ul style="list-style-type: none"> <li>■ Open an account or provide account information.</li> <li>■ Give us your income info or direct us to buy/sell securities.</li> <li>■ Enter into an investment advisory contract.</li> </ul>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>■ Sharing for affiliates' everyday business purposes—information about your creditworthiness.</li> <li>■ Affiliates from using your information to market to you.</li> <li>■ Sharing for nonaffiliates to market to you.</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>

Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>■ We do not jointly market with nonaffiliated financial companies</li> </ul>
